Taylor kicked off the meeting by welcoming everyone at about 10:02 a.m.

#### 1. Changes/adjustment to agenda:

Taylor asked for any changes to the agenda. Hearing none proposed, he continued.

#### 2. Minutes – September 17, 2021:

Taylor requested a motion to adopt the previous meeting minutes. Jamie Stewart moved acceptance of the previous meeting minutes. Sam Andersen seconded the motion, which passed by voice vote.

## 3. Task #3 - Engagement

A. Taylor requested that people complete the tracking document on the website for the different people they have spoken with. Taylor also asked everyone to create a short memo on the themes that have emerged from their one on one meetings.

B. Taylor next asked how different outreach was going in each region.

Central Vermont: Jamie noted that he had contacted the CV Region's CAP. Jamie noted that access to capital remains an issue for startups.

<u>Addison County</u>: Fred stated he had contacted all his statewide agency contacts and conducted interviews. John noted ACRPC/ACEDC had completed 8 focus group meetings and sent the business survey to all advisors.

Chittenden: Regina noted that Chittenden had 20 individual meetings so far. Housing and childcare emerged as the primary themes.

<u>Rutland</u>: Tyler noted he had done some work with the Center for Rural Innovation. Amanda noted she had also engaged in several meetings. More work ahead.

- C. Focus Groups: Other Focus groups are moving forward slowly. Group need to understand what CEDS can do for them before they spend a lot of time engaging. Many are tired of organizational planning outreach, having just recently completed several from other groups.
- D. Review of Statewide Reports: Taylor reported they had created a good list of current reports. Taylor has created a form to summarize each report so the team can synthesize consistent information for each report into the CEDS. Taylor and Sarah will look to complete their review of other reports by the November meeting.
- E. Employer Survey: Taylor noted we had received 124 responses to date. Taylor will pull the data and send it to the RDCs to evaluate. RDCs will determine whether or not to advertise the survey further or close it.
- F. Workshop #2 The group decided to postpone the workshop planned for November 18th until the spring. The workshop will be one large group with no breakout rooms. We will share the information we have collected to date. Between now and then we will take the time to organize our strategies. We will organize strategies by theme and sector. We will emphasize the Bipoc engagement the group has engaged in to ensure all recognize the validity of the work. Feedback on strategies should be prioritized and lead to prioritized project lists.
- G. \$20,000 Consultant funds Taylor will reach out to Xusana Davis, inform her of our actions to date and ask whether she has other recommendations regarding outreach.

- H. Website Amanda reported that the website is up and running. She encouraged all to visit it. **She will review the website analytics prior to the** next meeting and report on its use for the November meeting. She will also make sure any updates to SOARs anyone sends her are posted.
- I. UVM Data As part of Rutland's work on the website in the future, we will need to decide on our specific data indicators and the platform we will use. We will also need to figure out the CEDS relationship to UVM and the data they keep and maintain and how that data might feed the CEDS.

### 5. Task#5 - Economic Trends and Statewide CEDS Coronavirus Appendix

Ken Jones noted that EDA will give the Governor \$1,000,000 to have the administration help coordinate the state's efforts to respond to the Coronavirus. Ken wants to ensure that this CEDS effort links directly to that funding. He wants us to focus on infrastructure and believes the priority lists we are developing for this CEDS and generally will help focus the discussion. Ken will provide a list of sectors for the CEDS to focus on next week to enable our CEDS work to coordinate with his work for the administration.

6. November Agenda - Outreach Update and CEDS Outline and Discussion, Workshop 2 planning, update on the Website, RPC/RDC Discussion of Resources to ask ACCD to deploy.

Adjournment: Sam Andersen moved to adjourn, Jamie Stewart seconded the motion. By unanimous consent, Taylor adjourned the meeting at 11:36.
